

AGREEMENT

AGREEMENT made this ____day of ____by and between , **METAMORA HUNT, INC.** a Michigan non-profit corporation, (hereinafter “the **HUNT**”), and _____, (hereinafter “**Advertiser**”),.

WHEREAS, Advertiser desires to purchase Advertising Space on the Metamora Hunt website, and

WHEREAS, The Hunt is willing to accept said purchase offer, provided the terms and conditions herein provided are complied with,

NOW, THEREFORE, based on the mutual promises and covenants contained herein the parties agree as follows:

1. The following definitions shall apply herein:

"Advertising Space" means one banner Advertisement, stored on the metamorahunt.com server, with a defined Start Date.

"Advertisement" means the graphic file supplied by an Advertiser which can be selected by a user as a Link.

"Link" means a request for information from a server other than the metamorahunt.com server.

"Slot" means an HTML page which may include a metamorahunt.com Advertising Space and the Sponsor's Advertisement.

"Start Date" means the first day the metamorahunt.com server will display the Advertisement.

"metamorahunt.com server" means a server computer maintained by the Hunt's web services provider that users may access via the Internet.

"Impression" means the number of times an ad banner is viewed.

2.PAYMENT.

Advertiser and its authorized advertising agent shall pay the contract amount in full prior to the Start Date. Upon receipt of payment in advance the Advertiser shall be allotted an on-line banner ad on the Hunt's website, metamorahunt.com. For payment of \$250.00, advertiser is entitled to one (1) Primary Page Advertisement for twelve (12) months, in rotation with up to a total nine (9) other banner advertisers.

3.SPECIFICATIONS.

The advertiser shall furnish to the Hunt a banner advertisement meeting the following specifications:

Images

- Sponsor Corner Image's width should be 256px and height not to exceed 183 px with 128 px considered ideal
- Should be 72 DPI

*A photo editing tool the advertiser may choose to use is IrfranView (<http://www.irfanview.com/>). Download the current version.

- To resize a photo and make sure it is 72 DPI go to : Image > Resize/resample

The advertisement accommodates the advertiser's logo and tagline/link to advertiser's website. Refer to the Metamorahunt.com website for an example.

3.ADDITIONAL ADVERTISING.

Additional advertising may be purchased under this agreement in six (6) month increments by paying an additional fee of \$125 within thirty (30) days after receipt of invoice. The Hunt shall reserve _____ guaranteed months of banner advertising from the Start Date of _____ on the www.metamorahunt.com server.

2. RIGHT TO REFUSE UNACCEPTABLE ADVERTISING:

THE HUNT reserves the right to refuse any advertisement sponsorship banner that does not conform to instructions and guidelines set forth by its web services provider. THE HUNT cannot guarantee accurate or timely placement of any advertisement graphic that does not arrive seven (7) days before the start date. In addition, THE HUNT may in the exercise of its sole and unfettered discretion, refuse advertising that it deems to be inappropriate.

3. USAGE STATISTICS:

THE HUNT MAKES NO GUARANTEE OF ANY LEVEL OF TRAFFIC AT ANY GIVEN TIME or the number of impressions an advertiser may receive for their banner advertisement or the number of times the advertisers link may be selected. THE HUNT IS NOT SUBJECT TO CLAIMS OF LIABILITY REGARDING PUBLISHED OR UNPUBLISHED USAGE STATISTICS. NEITHER THE HUNT NOR ITS WEB SERVICES PROVIDER IS EQUIPED TO PROVIDE ADVERTISERS WITH USAGE STATISTICS.

4. TRUTH IN ADVERTISING / INDEMNIFICATION.

Advertiser bears sole liability for any claims arising out of or relating to (1) the Advertisement, and/or (2) any material to which users can link through the Advertisement. Advertiser hereby represents and warrants that the Advertisement and Link comply with THE HUNT's advertising standards; and that advertiser holds the necessary rights to permit the use of the Advertisement and Link by THE HUNT for the purpose of this Agreement; and that the use, reproduction, distribution, or transmission of the Advertisement will not violate any criminal laws or any rights of any third parties, including, but not limited to, such violations as infringement or misappropriation of any copyright, patent, trademark, trade secret, music, image, or other proprietary or property right, false advertising, unfair competition, defamation, invasion of privacy or rights of celebrity, violation of any antidiscrimination law or regulation, or any other right of any person or entity. This Agreement will be governed by and construed in accordance with the laws of the State of Michigan.

This Agreement represents the understanding between the parties with respect to the subject matter hereof, superseding and replacing any and all prior agreements, communications, and understandings (both written and oral) regarding such subject matter. The terms and conditions of this Agreement will prevail over any contrary or inconsistent terms in any purchase order. This Agreement may only be modified, or any rights under it waived, by a written document executed by both parties.
